Agenda item 13: Immigration Policy and Legislation Development

Recommendations

The PIDC Regular Annual Meeting is invited to:

- a) **note** the update provided regarding the PIDC Policy and Legislative Modernization Programme and the work undertaken in partnership with Members to strengthen their legal and policy frameworks;
- b) **welcome** the experiences shared and lessons learnt especially during the COVID-19 period where remote support was the only possible mode for delivery; and
- c) **encourage** the Secretariat to continue working with Members in supporting their respective legislation modernization programmes.

Purpose

This session provides an opportunity for Members to discuss and share their experiences in developing their respective legislation as part of the PIDC Policy and Legislative Modernization Programme.

Background

2. A key PIDC priority has been to support PIDC Member Countries and Territories modernise and strengthen domestic immigration legislation and policy where appropriate according to relevant international standards and best practice.

Legislation Review Programme

3. Table 1 below provides a summary of the PIDC Policy and Legislative Modernization Programme. Three Members were scheduled for support in the 2021/22 financial period including the Solomon Islands, Tuvalu and Niue, while ongoing work to finalise Samoa and Tonga's legislation review project continues. Delays were experienced in engagement and delivery in several instances caused mainly by the continued spread of COVID-19 across the region as well as domestic issues related to natural disasters and civil unrest.
